### 1. Background

**5. Other areas of co-operation**

**DSBM** and **B-ONE BUSINESS HOUSE PVT. LTD.** will also explore other potential areas where cooperation would be of exclusive mutual benefit of the students' community.

**6. Intellectual Property Rights**

**6.1** All intellectual property content that is developed jointly by the Parties after the commencement of this MoU will be jointly owned by the Parties and subject to any other terms and conditions that will be worked out on a case-to-case basis, as may be agreed upon in writing.

**7.1** The parties declare it to be their intention that this MoU shall operate between them in accordance with the principles of good faith, with fairness and without detriment to the interests of anyone.
