### 1. Background

- 4.2 Summer Internship Programmes for students of B. Com and BBA as per the university curriculum subject to availability of slot.

**5. Other areas of co-operation**

**DSBM** and **Amber** will also explore other potential areas where co-operation would be of exclusive mutual benefit of the students' community.

**6. Intellectual Property Rights**

**6.1** All intellectual property content that is developed jointly by the Parties after the commencement of this MoU will be jointly owned by the Parties and subject to any other terms and conditions that will be worked out on a case-to-case basis, as may be agreed upon in writing.

**7. Good Faith**

**7.1** The parties declare it to be their intention that this MoU shall operate between them in accordance with the principles of good faith, with fairness and without detriment to the interests of anyone.
